On this _____ day of _____ 20____, the above-described dog of the Doberman Pinscher breed is being sold to the above described person(s), under this agreement. Breeder guarantees the above-described dog to be free of any parasites and in good health at the time of purchase. If, within forty eight (48) hours of the sale date the above buyer(s) has veterinarian proof that the above puppy is ill, then the buyer agrees to return the above dog to the breeder. The breeder will either return the dog in well condition or will replace the puppy. Should a replacement dog ever become necessary, the breeder agrees to furnish a puppy out of the same litter or a future litter equal in quality, (quality meaning "Show prospect" quality) to the original puppy. Should the buyer(s) take the above puppy to the veterinarian or incur any expenses, the breeder shall not be held responsible for any or all expenses. It is further understood, that under no circumstance will there be a refund of the purchase price.

The DARWIN kennel name must be used on the first part of this puppy's registered name. No other kennel names will be allowed on this puppy's registration, unless otherwise agreed upon by the breeder.

The above puppy is being sold as "Show Prospect" and the breeder guarantees against disqualifying faults (4 or more missing teeth, overshot bite more than 3/16" or undershot bite more than 1/8", or one or more missing testicles). If the above puppy has any disqualifying faults, the buyer(s) can return the puppy to the breeder for another "show prospect" of equal quality or at the breeders option, the buyer(s) can spay or neuter the above puppy and send a

veterinarian certificate of such to the breeder and keep the dog. The breeder will then agree to sell the buyer(s) another "show prospect" for pet price.

AKC registrations have an expiration date. The buyer(s) are aware of this expiration date and initial here:_____. The breeder will not be help responsible for AKC papers after that date.

The buyer(s) agree to give routine veterinarian care (shots, exams, fecal, dental, etc.) to feed a premium dog food, to keep the above described dog healthy and happy, to train and to love and care for this dog for its lifetime.

The above described dog is being sold as a "show prospect" and a family pet, housedog, and a member of the family and will not be kept as a kennel dog, tied up, live entirely outside, or be used as a guard dog. If for any reason, the buyer(s) are not caring for the dog as agreed to in this contract, the breeders: Darlene Young and Marilyn Altheide have the right to take the possession of the above described dog.

Buyer(s) agree to never breed the above described puppy to any dogs that have the White Factor in their pedigree.

If for any reason the buyer(s) cannot keep the above dog, it is agreed the breeder(s) will be notified immediately and may request the dog be returned. Any or all liabilities, expenses or liens that have occurred on the dog prior to its return to the breeder will NOT be the breeder's responsibility. The buyer(s) also agree to send complete medical records and AKC papers with the dog upon its return to the breeder.

If the buyer(s) have questions about their new dog, they will call the breeder(s). They are there to help guide and are will provide the buyer(s) with a "puppy packet" containing much of the information needed in raising the puppy.

The breeder's representation that the puppy is of sound temperament is based on observation of the puppy and knowledge of its ancestry. This means the puppy is sound when the buyer(s) purchases it. The buyer is aware that behavior is based on genetics and environment. Improper training and neglect can spoil good genetic temperament. The buyer(s) must call the breeder for advice if unsure of how to deal with a particular behavior of the puppy. The breeder is not responsible for the behavior of the puppy after it has been with the buyer(s) for 30 days.

The above puppy is being purchased for the price of \$_____the purchase price includes the ears cropped, deworming and shots up to the date of purchase.

This contract is non-transferable. Only one signature is required from Marilyn Altheide or Darlene Young, the breeders. But all new owners must agree and sign this contract.
